

There Are Now 5 Live Trademarks With The UNKNOWN[DD] Design Code Description

Today, the Current TESS search **UNKNOWN[DD] NOT DEAD[LD]** retrieves 5 trademarks with the UNKNOWN design search code 030116 - the UNKNOWN design search code problem is expanding!

On TESS Beta, the search DD:"Heads of cats" retrieves those 5 trademarks from the Current TESS search **UNKNOWN[DD] NOT DEAD[LD]** mentioned above. Conversely, the Beta search DD:"Heads of felines" retrieves 4,350 live plus 752 dead trademarks - that **03.01.18 - Heads of felines, including cats of any size** is the **preferred design code for heads of cats** - that design code **03.01.16** does NOT occur in the Design Search Code Manual - that one or more data entry folks for design search codes has a BOGUS entry **030116 for heads of cats** that is adding invalid design search codes to the trademark search data.

That copy/paste appears to have succeeded. Note that design search codes are **NOT** displayed - that TESS Beta user do not get hints for searching similar designs from the Beta listing. For contrasts, here's the copy/paste directly from current TESS to email (highlighting mine)

Both versions of TESS displays the **CafÃ©** blemish in the GS entry.

Viewing the raw application on TSDR, note the GS entry as submitted.

Clearly, USPTO processing converted Café services; to CafÃ© services;. Shouldn't the USPTO fix that blemish?

Then there's the **03.01.16 - UNKNOWN** design code entry.

As it happens, the current TESS search **UNKNOWN[DD] NOT DEAD[LD]** retrieves this application. The equivalent TESS Beta search **DD:UNKNOWN AND LD:TRUE** **does not** retrieve this application, but curiously the TESS Beta search **DC:030116** retrieves this application - that the build of TESS Beta added

the design code but did not add the design description UNKNOWN when an unrecognized design search code was encountered during the build of the search database. Shouldn't the database build for TESS Beta add **UNKNOWN** as the design description just as current TESS does, versus making that unrecognized design code essentially invisible?

the problem 03.01.16 is not shown, but digging a little deeper on TSDR, the Notice of Design Search Code document on TSDR shows

The USPTO has assigned design search codes to your application (U.S. serial number: 98169794).

Design search codes assigned to your application:

03.01.04 - Cats in the nature of housecats
03.01.04 - Domestic cats
03.01.04 - Kittens
03.01.16 - Heads of cats, dogs, wolves, foxes, bears, lions, tigers

essentially confirming that the 03.01.16 design code is hiding somewhere in the data for this application.

Searching the Design Search Code Manual, the entry 03.01.18 - Heads of felines seems appropriate, though I do NOT see either heads of felines or heads of cats in the alphabetical index. Maybe the design search code folks might get a Heads-Up about this to update the alphabetical index with design code 03.01.18. Then again, searching 030118[DC] on current TESS does retrieve multiple hits with the 03.01.18 - **Heads of felines**, including cats of any size design description. Makes you wonder where they found that description, doesn't it?
